

DIRECTIONS FOR USE

Precaution: MAXX-PHITE is a highly concentrated material. Exercise precautions to prevent potential root or foliar burning, or soil media pH changes. If applying MAXX-PHITE in combination with other materials, a compatibility test is recommended to avoid potential incompatibilities. Prior to the addition of MAXX-PHITE to a spray mix, the user or application advisor must have experience with the combination or should have conducted a phytotoxicity trial. Do not mix with fixed copper or copper-based fungicides if the pH of the spray solution is below pH 6. Use sufficient water to ensure thorough coverage.

COOL SEASON TURF Fairways	2 - 4 oz./1000 ft ²	Apply every 2 weeks in a minimum 1.5 gallons of water / 1000 sq. ft.
Greens	2 - 4 oz./1000 ft ²	Apply every 1 to weeks in a minimum of 2.0 gallons of water / 1000 sq. ft.
WARM SEASON TURF Tees, greens & approaches	3 - 6 oz. / 1000 ft ²	Apply every 2 weeks in a minimum of 1.5 gallons of water / 1000 sq. ft.
Home Lawns & Sports Fields	3 - 6 oz. / 1000 ft ²	Apply every 2-4 weeks in a minimum of 2 gallons of water / 1000 sq. ft.
LANDING AREAS, FAIRWAYS & SPORTS TURF	1.5 gallon / acre	During cool, wet weather, apply every 14 days. Apply every 30 days during active growth periods. Apply in a minimum of 100 gallons of water / acre
OVERSEEDING, SPRIG- GING OR LAYING OF SOD	1.5 gallon / acre	Apply post germination, sprigging or laying of sod and at 14 day intervals thereafter in a minimum of 200 gallons of water / acre

MIXING INSTRUCTIONS

Prior to any fertilizer or pesticide application, all spray mixing and application equipment must be cleaned. Fill the spray or mix tank one half full of water and begin agitation. Add pesticides and/or fertilizers as directed by labeling or in the following sequence:

MAXX-PHITE is a formulated fertilizer treatment for summer stress in turfgrass and contains potassium phosphite. This product is intended to be used as a supplement to a well-balanced fertilizer program. It is not intended to be a substitute for sound soil fertilization and conventional cultural practices. Thorough coverage of foliage is necessary for best results when used as a foliar treatment. Foliar fertilization is intended as a supplement to a regular fertilization program and will not by itself provide all the nutrients normally required by turfgrass crops. Avoid foliar application under extremes of climate or stress.
