Nature Safe 10-2-8 with PBS 150 will give turf managers season long control of localized dry spots. It will also allow management of the hydrophobic soil conditions, while providing up to a pound of nitrogen per thousand.

### Directions for Use

For use on Golf, Lawns, and Sports Turf. Two 1/2 pound applications of Nitrogen will give 100 plus days of water management in a wide range of soil conditions. Apply 5 lbs. per 1000 sq. ft.

The spreader settings are conservative and should only be used as a guide for calibrating your spreader. Ground speed for Vicon & Lely settings was 4.5 mph.

### General Information

Nature Safe: The 1.00% Water Soluble Nitrogen of Nature Safe 10-2-8 will provide green-up in 7-10 days. The 9.00% Water Insoluble Nitrogen will release for up to 7-8 weeks.

PBS 150: Granular is a long-term surfactant utilizing a unique multi-branched surfactant molecular structure to address the source of performance loss - biodegradation of the surfactant molecule by soil microbes. This increased performance can reduce hydrophobic conditions on a sustainable basis for up to 150 days. PBS 150 Granular can also restore the uniform movement of water into and through the soil profile. PBS 150 Granular is easy to use and can be applied at any time of the year to avoid the detrimental impact of water repellency stress and localized dry spots. PBS 150 Granular is safe and will not harm turf when used as recommended. PBS 150 Granular should be applied early in the season before localized dry spot conditions and formations occur.
